What is ORGANIC?

A PRODUCTION METHOD

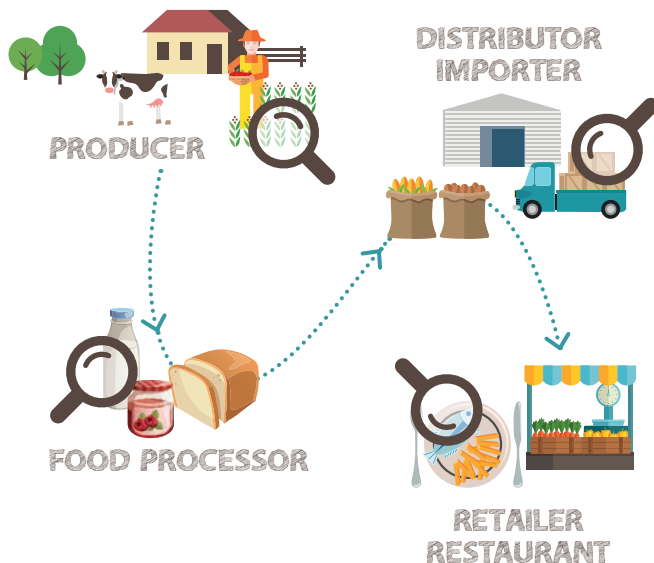
Organic farming is a **production method that is respectful of man, animal and the environment.**

Working with natural cycles, organic farming maintains biodiversity and improves soil fertility. **Crop protection products, artificial fertilisers, antibiotics or additives** are strictly limited and GMOs are banned.

Organic is a protected designation. The rules governing these production methods and crop outputs have been streamlined in European regulations, with each Member State responsible for the implementation thereof in their own country.

CERTISYS is recognised and accredited as an inspection and certification body by the regional authorities in Belgium and Luxembourg, and accredited by the Ministry of Economic Affairs (BELAC no. 093 PROD). Certisys is also recognised by the European Union for ORGANIC certification in Africa and by the US authorities for the NOP (National Organic Program).

Meet with your CERTISYS inspector for the first visit (approval verification).

4 Your ORGANIC certificate

As soon as your activities have been found compliant, you will be sent your ORGANIC certificate.

5 Your ORGANIC communications

The ORGANIC products specified in your certificate may qualify for the ORGANIC designation (logo, certificates, labelling, marketing and communication documents, etc.).

6 Ongoing ORGANIC monitoring

Your inspector follows up on your activities throughout the year. He will visit you several times each year, as part of ad hoc and annual inspections.
